

## Terms & Conditions – “No Name by DOLCEA” Contest

### INTRODUCTION

1. The “No Name by DOLCEA” Contest (“Contest”) is organized by **Nozomi Perfumery Malaysia Sdn Bhd** (“Organiser”) and is subject to the Terms and Conditions herein.

### CAMPAIGN PERIOD

1. The Contest will run from 00:00am, **1<sup>st</sup> March 2026 to 23:59pm, 30<sup>th</sup> April 2026** (“Contest Period”). The Organiser reserves the right to vary, postpone, shorten or extend the Contest Period without prior notice.
2. All entries received outside the Contest Period shall be automatically

disqualified. **ELIGIBILITY**

1. The Contest is open to all participants above 18 years of age (“Participants”).
2. The following group of persons are not eligible to participate in the Contest:
  - a. Employees of the Organiser, including its affiliated and/or related companies and their immediate family members (i.e. spouses, children, parents, brothers and sisters, including their spouses); and/or
  - b. Representatives, employees, servants and/or agents of distributors, advertising and promotion agencies or all such related parties of the Organiser, including their affiliated or related companies, and their immediate family members (i.e. spouses, children, parents, brothers and sisters, including their spouses).

### CONTEST MECHANISM

1. To participate in the Contest, each Participant must:
  - a. Purchase one (1) DOLCEA NO NAME 50ml perfume at any participating online platforms (TikTok, Shopee, Lazada – DOLCEA Malaysia Official Store) within the Contest Period. One (1) such single sales receipt entitles each Participant to one (1) submission.
  - b. Scan QR code at the back of the DOLCEA NO NAME perfume to go the contest landing page. Fill in all particulars required in the page and submit your respond in the designated field.
  - c. Retain ALL original printed sales receipts (dated within the Contest Period) as per ALL the entries sent THROUGHOUT the Contest Period as proof of purchase. Only valid printed sales receipts (including printed e-receipts from online purchases) dated within the Contest Period with clear details of DOLCEA NO NAME Perfume in the receipt will be accepted.

2. Multiple entries are allowed per Participant but all entries have to be unique with different receipts. Eg. Participants cannot enter 2 times with the same receipt.
3. The Organiser and the companies involved in the Contest shall not be held liable in any way for delays, non-deliveries and/or interruptions of the submission sent via the online contest page and shall not be held responsible for any unauthorised use of the Participants' details in conjunction with the Contest.

## **SELECTION OF WINNERS**

1. **One (1)** winner for each Perfume For Him and For Her will be selected in accordance with the terms herein and will receive the prize. Only Participants who fulfill the Contest Mechanism and requirements stated above will be eligible to be the winners. Participants who fail to fulfill the Contest Mechanism and requirements will automatically be disqualified from the Contest without notice.
2. Winners will be determined by randomized name selected from the pool of eligible participants by the Organiser.
3. Eligible prize winners will be announced by the Organiser on our official brand account on various online social platforms (**TikTok, Instagram, Facebook**), or any other URL to be determined by the Organiser and subsequently be contacted by the Organiser via telephone/email within six (6) to eight (8) weeks from (**end of campaign date**) and shall be required to provide the original printed sales receipt that matches the winning entry as proof of purchase before being declared as winners. Should the first attempt to contact the eligible prize winner fails, i.e. no reply, telephone number not in service or no connection, etc, another three (3) attempts will be made within the next 24 hours from the first telephone call. Where such further attempts are unsuccessful, the Organiser reserves the right to select the next eligible prize winner. The Organiser will not be held liable in the event the eligible prize winners cannot be contacted for whatever reasons.
4. The chosen eligible prize winner is required to present: (i) the original printed sales receipts; and (ii) a photocopy of NRIC as proof of purchase and identity during prize collection at the designated meet-up point provided by the Organiser. Failing which, the Organiser reserves the right to disqualify the eligible prize winner and find the next eligible winner as replacement.

## **PRIZE**

By participating in this contest, the winner shall not have any right to claim nor request for any compensation on revenue and profits made from the sale of the final product.
6. The winner should further agree and consent in full to the organizer to arrange suitable timing with the winners to record video and photo footages for contents which will/may subsequently feature in the organizer's official brand account across its social and e-commerce platforms.

### **ORGANISER'S RIGHTS**

1. The Organiser reserves the right at its absolute discretion to increase or reduce the number of prizes or substitute any prize with that of similar value at any time without prior notice. All prizes are not transferable, refundable or exchangeable for cash or in any other form for whatever reason.
2. The Organiser reserves the right to amend, delete or add to these Terms and Conditions without any prior notice at any time and the participants agree to be bound to such changes.
3. The Organisers' decision is final. Any letters, enquiries, appeal or protest will not be entertained. Participants hereby agree that no further action will be taken against the Organiser.
4. The Organiser may also at its absolute discretion cancel, terminate or suspend the Contest at any time with or without prior notice and reason. For the avoidance of doubt, cancellation, termination or suspension of the Contest by the Organiser shall not entitle the Participants to any claim or compensation for any losses or damages suffered or incurred as a direct or indirect result of the cancellation, termination or suspension.

3. The Terms and Conditions shall be governed by and construed in accordance with the laws of Malaysia.
